ORDER OF BUSINESS

A. Facility Assessment Study Contract Award (Action Item)

Mr. Daniel Romzek, Director of Business Services, recommended to the Board of Education a consulting contract for a facility assessment of all our District buildings and components. There were seven proposals submitted from vendors for this facility study. The lowest bid came in from Partners in Architecture, PLC, in Mt. Clemens. This firm worked in partnership with Wold Architects and Engineers during the District's 2002 bond renovations. Partners in Architecture, PLC is familiar with the District and the buildings. Mr. Romzek recommends the District award the facility assessment contract to Partners in Architecture, PLC in the amount of \$11,550.

D. Review of Draft 5 Year Financial Forecast for Deficit Elimination (Informational Item)

Mr. Daniel Romzek, Director of Business Services, presented the Board of Education with a Proposed Budget Amendment 2015/2016 General Fund PowerPoint. The complete PowerPoint and the 5 Year Financial Forecast for the Deficit Elimination can be found on the Hazel Park Schools website under the Open Schools Transparency & Accountability Data tab or in the office of the Superintendent.

Mr. Robert Moore, Oakland ISD, Deputy Superintendent of Finance & Operations, and Dr. Vickie Markavitch, Oakland ISD, Chief Executive Officer of Field Services/Cost Recovery, spoke on the District's financial situation. Mr. Moore complemented the District on their vast financial improvements since January 2015. He gave an overview of the District's deficit since 2007. Mr. Moore spoke about the District's upcoming visit to the Department of Treasury and what the District may expect. He stated that with the new legislation enacted on the Early Warning school districts such as Hazel Park the Treasury may require additional reporting. The District may not be able to approve their own bargaining agreements or large contracts. However, he does feel optimistic with the great "turn around" story the Superintendent has to tell to the Treasury. Dr. Markavitch reflected on the audit report. She stated that Hazel Park Schools has the "can do" attitude and that will make the difference. Dr. Markavitch stated that Oakland Schools is available to be part of the Hazel Park School Team as long as Hazel Park School wants them.
