1. On Tuesday, November 4 (Election Day) **Dennis Lewis** presented Safe & Secure Schools: An Interactive Workshop for Enhancing School Safety from 8:00 a.m. – 3:00 p.m. Virtually ALL employees attended. This presentation was held at the high school.

Dennis Lewis is an author, consultant, and co-founder of Edu-Safe LLC. He served seventeen years as the Director of School Policing for a large urban/suburban school district in the Midwest. He currently makes 100 plus presentations each year on the topics of bullying prevention, crisis planning and management, managing aggressive and violent behavior, student threat assessments, and the legal and practical application related to student searches. Additionally, he provides expert consulting and testimony for litigation.

Many people offered positive comments about his message. Everyone was given the opportunity to learn worthwhile things related to school safety.

- 2. For the first time in 15 years the **HP Viking Marching Band** qualified to compete in the State Finals at Ford Field on Saturday, November 1st. The top 49 bands in the state, 12-13 in each division, or Flight, come to Ford Field to compete one last time for the season and get their final ranking of the year. Attending the show are only the best in each Flight and if you are invited it means that you are one of the top bands in the state. Hazel Park went into the competition ranked in 13th place and held that position with a great score of 82. There were a mere 10 points separating the entire Flight so the competition was very stiff. Our small band of 58 students went up against bands that numbered up to 200. Flights are not decided by band size but by school enrollment; creating a wide range of numbers. Our band, though small in numbers, filled the field and definitely put on a show to be talked about. The school administrators, teachers, families, alumni and community members who turned out in mass to cheer them on showed pride in this band. Hazel Park pride shone brightly at Ford Field. The students accomplished a lot this season and they set the standard high for the bands to follow. The Vikings are on their way to making this an annual event.
